Carpet & Furniture Extraction:

Portables: 1 oz. per gallon of water (128:1)

Truckmounts: 32 oz. per 5 gallon stock (Meter)

Pre-Spray / Traffic Lane Cleaner:

Pump/Electric Sprayers: 4 oz. per gallon of water (32:1)

Injection Sprayers: Meter (32:1)

Hint: If you have a set injection sprayer at 8:1, you can fill 1/4 of the tank with chemical and 3/4 with water. The end result is 32:1.

Spotter: 4 oz per 32 oz. spray bottle.

Bonnet Cleaning: 4 - 6 oz. per gallon of water

pH (Concentrate): < 7 pH (1% solution)
